Call To Artists – WNF's First Plein Air Event and Auction

(Open to all mediums including painting,
photography, 3-D, and mixed media)

Silent Auction Date: Friday, June 27, 2008

20 artists will be chosen to participate in this event. Artists will be asked to create a work of art (plein air) on the farm, from June 1st through the 21st. Between June 22nd and 26th, the artwork will be on display at Wolfe's Neck Farm's office on Burnett Road. The artwork must be ready to display on easels or table (although wet paint is acceptable!). Publicity will cover this event, and visitors to the farm will be encouraged to observe and interact with the artists at work.

On Friday evening, June 27th the plein air artwork will be sold at a silent auction, to be held in conjunction with the Wolfe's Neck Farm *Art Fest*. This will be held at the Old Town Hall in downtown Freeport next to the Hilton Garden Inn, from 6:00-8:00 p.m. 25% of sales will be donated to Wolfe's Neck Farm and 75% will be sent to the artist. (If artists would like to donate more than 25% of their proceeds, this would be welcomed by WNF.) Artists are encouraged to attend the event, but it is not required.

Application and Notification

Artists are asked to complete the attached application and return it with supporting documents by April 10th. All submitting artists will be notified by mail of selection decisions the week of April 21st. No selection decisions will be released over the telephone or via fax or e-mail.
