- The show features only original, hand-produced work. Inside artists work will be juried. Although the outdoor artist space is not juried, the committee reserves the right to make selections based upon providing a quality show with a variety of products.
- Set-up is 3:00-5:30 p.m. on Friday, June 27 for the Old Town Hall/ Hilton artists; 7:00-9:30 a.m. on Saturday, June 28 for park artists.
- *Art Fest* Preview Party and art sale: Friday, June 27, 6:00-8:00 p.m.
- Public show hours are 10:00 a.m. to 4:00 p.m. on Saturday, June 28, 2008.
- Artists may quickly unload on Park Ave. but must park their vehicles in the designated area of the Hilton parking lot.
- Each artist is responsible for the collection, reporting and remitting of the State of Maine sales tax, if applicable.
- Set-up display fixtures are the responsibility of the artist. Electrical hook-ups are available in Old Town Hall/Hilton only.
- Each artist will be provided a packet of postcards and an information packet, including directions and other area information.
- The customer admission fee is \$2.00 and each attendee will receive a program.
- Application deadlines: (APPLICATIONS WILL NOT BE CONSIDERED WITHOUT PAYMENT)
 1. May 15 – park artists (including check and application)
 2. May 10 – Old Town Hall Artists (including check, application and PHOTOS OF WORK) –
Jurying will be completed by May 15 and refunds will be distributed as appropriate.
